#### -Safe gaurd your Finance

Online business fraud is escalating in India, with over ₹1,750 crore lost to scams in 2024. Fraudsters are exploiting payment gateways, causing money to be deducted from customers' accounts without reaching businesses. Additionally, fake calls and messages trick people into sharing sensitive financial information.

To protect yourself, verify the authenticity of businesses before making payments, avoid clicking on suspicious links or sharing sensitive details, and use trusted payment platforms. The government introduced the Special Business Registration Unit (SBRU), which requires businesses to register before contacting customers. Non-compliant businesses face penalties, and suspicious activities can be reported through the helpline 1930 or the National Cybercrime Portal. Stay vigilant and safeguard your online transactions.

## Financial concept

#### 1. Lease

The lessee rents an asset for a specified period with regular payments. At the end of the lease, they usually return the asset, though they might have the option to buy it. Eg: Government renting expensive machinery for infrastructure (eg cranes, bulldozers)

#### 2. Hire Purchase

The buyer hires an asset, making periodic payments. After completing the payments, ownership of the asset is transferred to the buyer.

Eg: Buying a car through EMI (ownership after full payment).
