An Interview with Prof. Mario Mascarenhas Visiting Faculty at ML Dahanukar College of Commerce.

If we as teachers can bridge the gap between theory and practice, it would immensely help the students.

1) What strategies do you employ to make subjects like accounts, wealth management and finance more engaging and accessible?

For practical subject like accountancy, I usually try to give practical examples so that students can learn and understand the concepts better. For students from vernacular medium, I prepare notes and sheets which are easy to understand and comprehend. For, theoretical subject like Financial Services and Wealth Management, again, I try to give latest examples from the industry and also share my personal experiences from the industry.

2) Generally, subjects like accountancy, wealth management, financial services need a balance between theory and practice, so how do you strike a balance between theory and practical applications in your teaching?

A teacher should know at least 200% more than he or she has to teach. If we as teachers can bridge the gap between theory and practice, it would immensely help the students. From time to time, our college management also ask us to suggest skill development courses for students. We have been conducting so many short- term courses for our students like Tally, Advanced Excel, Financial Modelling, Photography, Capital Markets, etc. All these courses give hands on experience to our students which will definitely help them in their professional life in the future.

3) Can you provide a brief overview of your experience teaching for 17 years?

I started teaching right after my post-graduation as a visiting faculty in M.L. Dahanukar College of Commerce. I was employed at the same time with Berggruen Advisors. So, my industry experience gave me the confidence to teach students because I had something more to share with them other than what was already mentioned in the text books. The students were very sincere and I am still in touch with most of them. They are doing good in life and that makes me very happy as a teacher.

4) What are your learnings from your 5 years of industry experience, and how do you integrate them into teaching?

Working in corporate has given me an insight of corporate life, the kind of work culture different organizations have, and, the kind of control systems they have to mitigate risk, documentation systems, communication, along with the planning that goes into each and every thing, the time management, continuous learning system etc. I try to incorporate the same things in my teaching. Time management and planning is required to complete the syllabus in time. We as teachers, must continuously keep ourselves updated.

5) What advice would you give to aspiring students to pursue their careers in fields like finance, accountancy and financial services, considering both the academic and practical aspects?

As we all know, our syllabus is not industry oriented. It is more of theory, less of practical application. Students may gain theoretical knowledge, but may lack practical application, as to how to apply the knowledge in professional life. So, my advice to students is that they should acquire some basic skills before joining the workforce. For students of commerce, it would be learning advanced excel or PowerPoint, which is very important in corporate life. Apart from that, when they choose their first job, they should choose something which will give them more exposure and salary should be secondary. Students should complete their higher education, before the start working preferably or along with their job, which is considered for promotion later on in profession life. So, my advice to students is that they should acquire some basic skills before joining the workforce.

NAVIGATING CRISES: STRATEGIES FOR EFFECTIVE DISASTER MANAGEMENT



This event took place over two consecutive days, on the 17th and 18th of January 2024. The event was held in the presence of the Incharge Principal, Prof. Dr. Kanchan Fulmali, Vice Principal Smt. Chandana Chakraborty, and professors Siddhi Kadam and Mansi Mule of M.L Dahanukar College of Commerce.

The event was led by Incharge Principal Prof. Dr. Kanchan Fulmali and Mr. Rajendra Lokhande (an expert in disaster management currently serving as the shift-Incharge in the Disaster Management Department at Brihanmumbai Municipal Corporation).

The ceremony included a symbolic gesture of connection and connectivity, represented by a Highlights disaster tulsi. for sampling of management emphasized staving calm, taking practical, responsive steps, and sharing experiences. Later, Mahesh Jadhav sir addressed emergency response doubts, while Mahendra Kambalekar and Pravin Bramadande shared practical tips and with lessons. **Participants** left a deeper understanding of disaster management and first aid in a two-day cohort.

Throughout his session, Rajendra Lokhande guided his students through practical steps and insightful remedies, demonstrating his vast knowledge. He holds degrees from Mumbai University in both commerce and law, along with diplomas from IGNOU and Open University. He is a dedicated life member of the Indian Red Cross and shared experiences from the Mumbai 2005 floods to the 2008 Taj Hotel attack, emphasizing the importance of preparedness and swift action in crises.







Mahesh Jadhav Sir is a resilient foreman in the fire brigade who cares deeply about keeping people safe. He shared many experiences from helping in emergencies on and off duty. He answered questions clearly, ensuring everyone understood what to do in an emergency. He taught important things that can help us protect ourselves and others in an event where something goes wrong.

Pravin Bramadande is an expert in disaster management, focusing on helping people through tough times. In his session, he taught how to provide first aid effectively and shared practical tips for assisting victims and ensuring their safety. He explained everything in a simple and understandable way, prioritizing the importance of being prepared and knowing what to do in important situations.

This two-day session wrapped up with everyone having a better understanding of how to tackle disasters. Industry experts shared their experiences, helping everyone to learn a lot. They explained what to do in emergencies along with practical examples to make it easier to understand. They demonstrated how to use fire extinguishers and perform CPR, and everyone left with knowledge and preparedness about what to do in such complex situations.

MISSION SHAKTI: INDIA'S GROUNDBREAKING ASAT TEST AND ADVANCEMENTS IN SPACE DEFENSE

India Launches Historic Mission Shakti: Successful Anti-Satellite Missile Test!" This achievement marks a significant milestone for India's space program. Certainly! Mission Shakti was a historic achievement for India's space program, involving the successful test of an anti-satellite (ASAT) missile on March 27, 2019. The mission was carried out by the Defense Research and Development Organization (DRDO), India's premier defense research organization.

During the test, an indigenously developed ballistic missile interceptor was launched from Abdul Kalam Island in Odisha. It successfully targeted and destroyed a live satellite in low Earth orbit, approximately 300 kilometers above the Earth's surface. The mission showcased India's capability to safeguard its space assets and demonstrated its technological prowess in the field of space defense.

The successful completion of Mission Shakti made India the fourth country in the world, after the United States, Russia, and China, to possess the capability to shoot down satellites in space. This achievement has garnered international attention and recognition for India's space program.

It's important to note that Mission Shakti was conducted purely for defensive purposes, with no intention of initiating an arms race in outer space. India has consistently advocated for the peaceful use of outer space and the prevention of the weaponization of space. While it's important to acknowledge the collective efforts of the DRDO and the team involved, specific individuals may not be publicly disclosed due to security and confidentiality reasons.

In DRDO, the ratio of female scientists is higher than that of males. This sends a positive message to India and the world, empowering women to do their best.

Mission Shakti not only showcased India's stand worldwide but also did not create any space debris as it was conducted in Earth's lower atmosphere. The debris created by the test fell back to Earth within weeks. The Ballistic Missile Defense interceptor of DRDO was used in Mission Shakti, as part of the ongoing defense program.

The success of Mission Shakti is a testament to the hard work and innovation of the scientists and engineers at DRDO, who continue to contribute to the advancement of India's defense capabilities.




ASHOK VADAPAV CENTER



The cherished restaurant was started by Mr. Ashutosh Joglekar's grandfather, who opened its first outlet in 1947 in Prarthana Samaj, a small neighbourhood in south Mumbai. Two decades later, the Dadar branch opened. The hotel servers have an unique way of styling, wearing khaki shorts and Gandhi caps. Customers fondly address them as 'mama'.



AASWAD UPAHAR AND MITHAI GRUH

The renowned restaurant was started by Shrikrishna Ganesh Sarjoshi and now owned and managed by his son Suryakant Sarjoshi. Sarjoshi came to Mumbai in 1988 from the interiors of konkan . He started out as a pitchman for Trupti restaurant (now latched). In 2015, Aaswad won London's Foodie Hub Global Awards for their outstanding missal.

GOMANTAK

Gomantak mainly serves seafood cuisine for all fish and crab lovers. According to Mohan Borkar, who co-owns the restaurant with his two brothers, his father founded Gomantak in 1947. He claims that the Gomantak next to Plaza in Dadar, which is also one of favourites, was founded by his cousins and was the first Gomantak restaurant in the city.



MAMA KANE




Established in 1910, Mama Kane is one of Dadar's old names. Narayan Vishnu Kane and his widowed sister, worked very hard to establish this eatery. The original name was Dakshini Brahmananche Swacha Uphargruha, indicating this little eatery's roots in the cuisine of the Brahmins of southern Maharashtra.

But it was more popularly known as Mama Kane as locals colloquially addressed in that manner. This restaurant was one of the earliest in Mumbai to put batata-vada on the menu. The intention with which the eatery started was to provide affordable, healthy home cooked food for workers and office goers. In 2010, on the occasion of completing a century they diversified their menu in Punjabi and Chinese cuisine.

FACTS ABOUT DADAR

- Dadar hosts specialized institutes like Institute of Hotel Management and NIFT.
- **.** Dadar hosts one of largest parks Shivaji park.
- Dadar is a prominent railway terminus on both the Western and Central lines of the Mumbai Suburban Railway network. Due to this, Dadar station is one of the most crowded stations
- In Marathi, Dadar means steps. The name "Dadar" refers to a short set of stairs constructed on the eastern side of Mahim Island. The station located next to these steps was given the name Dadar by the British when they constructed the Bombay, Baroda & Central India Railways (B.B.&C. I., currently known as the "Western Division" of the Indian Railways).
